


TERMS OF AGREEMENTS


1. This agreement is valid for a period of three years, and is extended further on mutual consent.

3. This agreement is governed by and construed in accordance with Indian law.

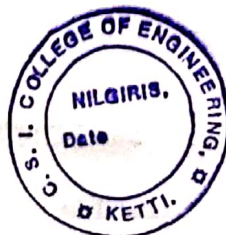
