4. Withholding results.

5. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
6. Suspension/expulsion from the hostel.
7. Cancellation of admission.
8. Rustication from the institution for period ranging from one to four semesters.
9. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

The Senior students of our College are hereby warned that they shall not indulge in "RAGGING". If they are found guilty of ragging they are liable for the above mentioned punishment.

The freshers / junior students are also hereby instructed that they should not respond to the calls from seniors, should not participate in any kind of party anywhere inside/outside the campus, even if ordered by the seniors and that, they have nothing to fear as the institution cares for them and shall not tolerate any atrocities against them.

The campus of CSI college of Engineering, Ketti is ragging free, still all these measures have been taken to ensure that the freshers are able to pursue their studies without getting teased, insulted or in any way troubled by the seniors.

All of this was possible only because of the whole-hearted support from students and teachers.
